


2021-2022-Reflection










Elections for Board of Directors

Team Staff, as registered with HEO Minor, shall also be a Member of the Association and shall be entitled to a vote unless already so entitled as a Player Representative. Special Membership may be granted by the Executive to persons who have demonstrated involvement and interest in the activities of the Association and shall be entitled to a vote unless already so entitled as a Player Representative"


• "Associate Members:

Individuals not resident within the WCMHA boundaries who have been properly transferred or waived in accordance with HEO Minor and Hockey Canada, shall become Associate Members of the WCMHA upon registration and payment of fees. Associate Members shall be Voting Members of the WCMHA"



Risk and Safety Report















- It was a challenging season having to navigate our way through COVID 2.0 while ensuring the safety of our players, parents, officials, volunteers, rink staff and our community
- The association followed guidelines in place by Ontario Public Health (OPH) and Hockey Eastern Ontario (HEO).
 - Screening forms were used as required to track teams be it association form or some teams used TeamSnap and their health check option
 - > Dealt with vaccination requirements as determined by HEO and the suspension of these players until compliant.
 - Managed any COVID outbreaks and reported to OPH and leagues when required.
- We will continue to monitor the ever evolving situation with respect to COVID-19 as we enter next season and
 - any requirements that come from governing bodies.
 - We continue to face some discipline issues with the association but the executive worked very closely with our RIC and the district representatives to foster our relationships this year.

We held a coaches meeting with RIC and had open and honest conversations and wwe want to continue to build on our relationships with officials.














Ice Scheduler's Report


